These documents are available for purchase from FCIA for use by ALL individuals involved in every aspect of fire and life safety systems in buildings.

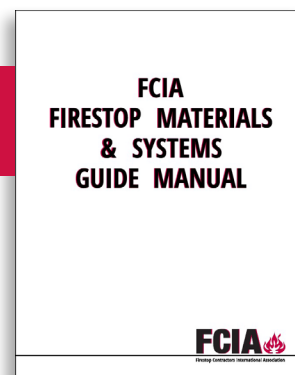

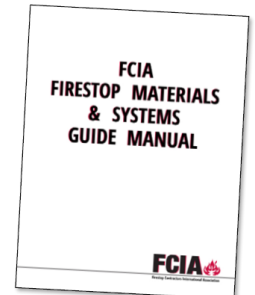
