- FM 4991 & UL-ULC Qualified Firestop Contractor Programs are regularly specified.
- ASTM E2174 & ASTM E2393 are required in the International Building Code and NFPA 1, and the mentioned in the appendix of NFPA 101.
- Maintaining Fire-Resistance and Firestopping Protection for the building life cycle is required in the International Fire Code, NFPA 1, and NFPA 101.

As a result of the combination of the FM 4991 Approved, UL-ULC Qualified Firestop Contractors, and Special Inspection for firestopping, Specialty Firestop Installation Contractors are being used 50% of the time, or more, on projects in North America and worldwide. The quality of installations is increasing, along with fire and life safety in buildings. The industry continues to grow. And so must the Association.

So, we are proud to announce our <u>new and updated Mission</u>, which encompasses our membership, our industry, our work. From Specialty Firestop Installation Contractors to Special Inspection Agencies, Associates to Manufacturers to Distributors,

FCIA & NFCA PARTNER FOR CANADA SYMPOSIUM

Fire-resistance-rated structural and effective compartmentation saves lives.

Structural protection is required when fire separations occur, under supporting construction. It is not one single system that contributes to safer buildings, but rather all the various aspects of fire-resistance-rated structural and effective compartmentation working in tandem that provide fire and life safety.

Recognizing this, the <u>Firestop Contractors International</u>
<u>Association (FCIA)</u> and the <u>National Fireproofing Contractors</u>
<u>Association (NFCA)</u> have teamed up to produce the <u>FCIA-NFCA</u>

Existing Building Fire-Resistance Symposium Canada in Ottawa, ON this September 20-22.

The Symposium features education on structural fire-resistance and firestopping and the National Building Code of Canada. Attendees will also be treated to a tour of the NRC Fire Test Laboratory in Ottawa, ON.

By taking this holistic approach to fire and life safety and by educating those who 'D'esign, 'I'nstall, 'I'nspect, and 'M'aintain fire-resistance, we can transform the fire and life safety landscape, one person, one penetration, one system, one building, one step at a time.

FIRESTOP CONTRACTOR ACCREDITATION PROGRAMS CONTINUE TO GROW

Third-party firestop contractor accreditation programs are gaining traction!

The value of the FCIA Member, FM 4991 Approved, or UL-ULC Qualified Firestop Contractor comes from the commitment to excellence. These important designations – FM 4991 Approved, UL Qualified, ULC Qualified, AND FCIA Member in Good Standing

 are being recognized by 07 84 00 Firestopping specifications in many occupancies around the world.

The result is an FM 4991 Approved or UL-ULC Qualified Firestop Contractor performing the work about 50% of the time. There are some occupancies and markets where the percentage is higher, some lower.

Third-party accreditation programs started as an idea in 1998 – a desire to globally set a standard for excellence within an industry to improve fire and life safety in buildings around the world. From then to now, it's inspiring to see the Contractor accreditation programs making a difference in the industry and in the built environment.





FIRESTOPPING SPECIAL INSPECTION

Firestop special inspection started from nothing, and look where it is now.

Picture this...Spring. 1999. The FCIA Education and Committee Action Conference.

Someone asked, "Why is there no inspection for firestop systems like fireproofing?"

Mike Pfeiffer, ICC VP of Codes, responded with, "Did you build a standard? And did you submit it to the code development process and get it approved?"

The FCIA answer was a round of "Nos".

Over the next 10 years, FCIA hired a consultant to develop the first draft and worked with manufacturers to create the Standards at ASTM. FCIA submitted the Standards for approval in 2002, 2005,

and 2009/2010, ultimately getting the Standards approved for the 2012 version of the International Building Code.

Now, 24 years later, firestop special inspection is being used in many areas. Inspection agencies are getting accredited in accordance with the International Accreditation Services IAS AC 291. Special inspectors are being approved by Authorities Having Jurisdiction based on their competence and experience in the same type and complexity of materials and projects inspected.

Firestop inspectors are gaining competence through education from the FCIA Education Program, firestop product manufacturer education, and other certifications. Knowledgeable firestop inspection agency personnel find non-conformances, report them, and demand corrections.

It's amazing what can happen when an industry works together to create better installations. Inspection certainly has helped, along with FM 4991 Approved and UL-ULC Qualified Firestop Contractors. Together, the meat in the 'DIIM' sandwich – 'I'nstallation and 'I'nspection – make firestop installation quality better.
