Chicago saw more than 30 people write the FM or UL/ ULC Firestop Exams. As these third-party accreditation programs continue to grow, this shows a strong commitment within the industry to installation excellence for safer buildings.

Education topics covered a wide-range of topics, from workforce recruiting and retention to two separate legal



issue programs, the new 2018 IBC adoption in Chicago to Code Development: Past to Now, and more. Sessions on Pump Maintenance and Productivity and UL Standards introductions led right into the FCIA tour of UL's Fire Test Labs.

We had a great discussion about the importance of specifying firestopping in one place, the MasterFormat Section 07-84-00. Using this single source spec, the Specifier can communicate to the Firestop Installation Contractors the documentation required to be passed on to the Building Owner and Manager.
