
This year's event takes place October 27-30, 2020 and features an agenda focused on critical elements of Barrier Management. Attend sessions on:

FCIA & THE ICC FCAC'S

The 2024 International Code Council's Code Development Processes are starting up. Code proposals for the 2024 Codes are due in January 2021.

In addition to the normal code development cycle, the ICC Board of Directors appointed several Code Action Committees (CAC's) to study issues that have trouble being resolved in two-minute sound bites at the code hearings. The CAC's provide teleconferences to working groups where interested parties participate in a forum to review issues, possible proposals, and much more.

FCIA has been participating in the Fire Code Action Committee (FCAC) working groups for several code cycles. The most recent discussion was the Chapter 7 working group discussions that cover a wide range of issues. Topics include T-Ratings, where fire-resistancerated joint systems are required, clarification of what the code means by fire walls, standards for doors, firepartition language, vertical openings, and much more. FCIA friends – Ed Goldhammer (Hilti), Rich Walke (FCIA), Bill Koffel (Koffel Associates), and others – participate and work on issues.

FCIA & FIRESTOP SYSTEM LABELS AT ASTM

CIA created a Recommended Professional Practice for 'Identification Systems', which included labeling of installed firestop systems. The RPP is in the FCIA.org <u>Members Only</u> section for use by members.

At the last International Code Council Building Code Development Cycle, FCIA submitted a proposal to require identification systems for firestopping. That proposal was disapproved. To have a better chance at passing in the next cycle, FCIA's <u>Standards Committee</u> is leading a task group at ASTM to develop a Standard that can be submitted.

FCIA & NEW STANDARDS

Over the past few months, you've likely seen webinars from many on the new M-Movement Ratings for firestopping, and much more. The M-Rating discussion was started by FCIA's Board of Directors over a decade ago. At that time, the Board requested that firestop test standards reflect – as close as a laboratory environment can do – what actually happens with the firestop system when used in actual buildings.

The Board's objective was to challenge the industry to develop products for better fire and life safety in buildings. And, the industry responded. Manufacturers, test laboratories, consultants, contractors, and others worked through the ASTM Standards Development Process to make things better.

Movement, exposure to elements, and more were discussed at ASTM to build better fire and life safety firestop systems for protecting breaches in fireresistance-rated assembles. These firestop systems were created for penetrating items, separation of adjacent spaces (joints), and building perimeter joint areas.

FCIA'S BOARD & COMMITTEES MEET - A LOT

While some are working from home and others from offices – safely separated – FCIA's <u>Board</u> of <u>Directors</u>, <u>Committees</u>, and Staff continues to meet via GoToMeeting and conference calls to keep a watchful eye on the industry and the Association's programs and financial well-being.

Conference calls have been monthly, sometimes more often, to discuss key issues affecting the industry and Association. The Virtual Committee meetings in April resulted in some great plans. We're working on those plans now and well into the future. Stay tuned to FCIA.org for news and updates on everything going on with your Association.
