#### FCIA ANNOUNCES CAREER FIRESTOP EDUCATION PROGRAM

The Firestop Contractors International Association announces the all-new *FCIA Firestop Certificate of Achievement Program* for Specialty Firestop Installation Contractor personnel and Firestop Special Inspection Agency personnel who want to immerse themselves in the world of firestopping and fire-resistance-rated and smoke-resistant assemblies.


The program features four (4) levels of VIRTUAL and / or Face-to-Face education starting in 2021. Participants in the *FCIA Firestop Certificate of Achievement Program* take part in virtual education modules covering all aspects of the firestop industry, starting with the 'DIIM' of Firestopping, continuing through Product and Systems Selection/Analysis, Estimating and Project Management, and ending with Preparation for the FM & UL-ULC Firestop Exams.


Each module culminates in a series of quizzes or exams. After passing the different level module assessments, participants are awarded a *FCIA Firestop Certificate of Achievement*.

**Firestop Level 1** is the entry-point module. Participants master content covering the elements of the <u>'DIIM' of Firestopping</u> to lay the foundation for the next section.

The **Firestop Level 2** curriculum consists of 20+ modules on firestop products and tested and listed systems assemblies, plus product and systems selection and analysis, and more.

Inspection Agency personnel, **Firestop Level 3** programming provides an understanding about specifications, estimating considerations, systems analysis, installation processes, documentation, variances, and maintaining protection from start to finish.

Finally, the **Firestop Level 4** module brings key information to Specialty Firestop Installation Contractor personnel seeking DRI status and Firestop Special Inspection Agency inspectors who need to prove competence in firestopping to the AHJ.

After taking and passing the <u>FM or UL-ULC Firestop Exams</u>, the person becomes a Level 4 *FCIA Firestop Certificate of Achievement* holder. When the Level 4 person is employed by a <u>FM 4991 Approved</u> or <u>UL-ULC Qualified</u> Specialty Firestop Installation Contractor, they can be appointed as a Designated Responsible Individual (DRI) by the firm. Inspectors can prove competence and be deemed Technically Competent by <u>IAS AC 291</u>, <u>Accreditation of Special Inspection Agency</u> <u>Companies</u>.

FCIA's NEW Firestop Certificate of Achievement Program is built on decades of experience and FCIA's Firestop Manual of Practice (MOP), the Firestop Containment Worker Education Program (FSCW), and Life Safety Digest. The FCIA MOP has been the basis for the FM & UL-ULC Firestop Exams from FM Approvals and UL-ULC since 2000 and 2006 for those seeking recognition worldwide.

### FM 4991 APPROVAL PROGRAM ANNOUNCES NEW CONTACTS

**CIA's** Accreditation Committee leadership recently met with FM Approvals to discuss ways to continue to build value in the FM 4991, Standard for the Approval of Firestop Contractors Accreditation Program. Among the topics of discussion were:

- The current status of the FM 4991 Approved Program;
  Almost 100 Firms are now FM 4991 Approved. This is a big accomplishment - from zero Firms when the program started in 2000 to 100 FM 4991 Approved Contractor Firms in 2021.
- The current policy for FM 4991 Approved companies and DRIs whose status expired in 2020 or are set to expire in early 2021;



# FCIA CODE COMMITTEE ACTIVE

CIA's Code Committee met to decide which code proposals to submit to the International Code Council's Code Development Process for the International Building Code.

FCIA's committee submitted proposals to 1) improve the firestop installation quality and 2) clarify joints and voids requirements to *'install in accordance with*  the manufacturer's instructions and listing criteria' (SYSTEMS). The Committee is also pursuing adding a requirement to identify the firestop system at the assembly.
