

FCIA AT ICC PUBLIC COMMENT HEARINGS

he <u>International Building Code (IBC)</u> and <u>International Fire Code (IFC)</u> is on a 3-year development cycle.

FCIA's participation at the Spring Committee Action Hearings brought some victories through approved proposals – and even victory in disapproved proposals. FCIA's Code Committee had building owner support for a proposal that would have mandated FM 4991 Approved or UL Qualified Firestop Contractors in the IBC.

In late September, we'll be in Pittsburgh to participate in the 2024 IBC and IFC Public Comment Hearings – with a few key proposals to support and oppose. Watch for a report in late fall.

FCIA AT ASTM

October 2019 was the last time the <u>ASTM Standards</u> <u>Development Process</u> held face-to-face meetings. The upcoming October ASTM Meetings will bring the firestopping industry together to discuss:

- **DRAFT Labelling Standard** Where should the firestop system number be located on a wall or floor? Next to the penetrating item, joint or on it? Under development and moving quickly is a standard to address these issues.
- ASTM E2174, ASTM E2393 the Firestop Inspection Standards, where there are always great industry discussions on better fire and life safety.

- ASTM E3038 the Firestop Inspector Competency Standard, to eliminate confusion of who the 'candidate' is – the company (pass one exam and everyone in the company gets a pass) or the individual (each person within the company).
- **ASTM E3157** the Firestop Guide, where further issues uncovered by FCIA will be discussed, and hopefully, resolved.
- Much more...

FCIA AT NFPA

The development of the 2024 version of the NFPA 101, The Life Safety Code, and NFPA 5000, Building, Construction and Safety Code, is moving along nicely. Committee meetings are taking place for the occupancy chapters, and results are being recirculated for ballot.

Watch for more on this in the near future as FCIA's efforts move forward.

FCIA AT NBCC

he <u>National Building Code of Canada</u> is on a 5-year development cycle.

FCIA has been working on trying to add building special inspection for firestopping, using the ASTM E174 and ASTM E2393 Firestop and Fire-Resistive Joint Inspection Standards.
