**~FCIA at ASHE** – FCIA's Marketing Committee will be at the American Society of Healthcare Engineers Professional Development Conference March 12-14, in Tampa. FCIA appreciates the relationship we have with ASHE, and looks forward to continued conversations.



**~FCIA at ASSE** – The FCIA Apprenticeship and Standards Committees, plus Accreditation, have been working with the American Society of Sanitary Engineers (ASSE) to keep the Standard for the Installation and Inspection of Firestop Systems around Piping a credible document for fire and life safety. Volunteers from the committees including; Mike Dominguez, Aedan Gleeson, Gary Hamilton, Bob Hasting, Eric Keeton, and Pat Tesche, along with Bill McHugh participated via Teleconference, while Pat Tesche and John Valiulis flew to Tucson for the meeting.

**~FCIA at UL STP / ASTM** – FCIA's Standards Committee is also participating in discussions with UL and the FCIA and IFC Member manufacturers at the UL Standards Technical Panel (STP) regarding shrinkage, movement and exposure being incorporated into UL 1479. The FCIA Standards Committee participated in teleconference and meetings February 8. Pat Tesche and Gary Hamilton travelled in, with Eric Keeton, Randy Bosscawen, Tracy Smith participating via teleconference. There is also discussion taking place at ASTM in April about these issues.

**~FCIA at ASTM** - New standards are being worked on and published at ASTM. FCIA continues to chair the ASTM E 2174 & ASTM E 2393 Standards, and is attending the April ASTM E 06 Meetings. We'll be discussing an update change to remove a nonmandatory language in one of the standards. Plus, we'll be working with ASTM Members on an 'installation guide', a very short document that addresses proper design and installation of firestop systems.

When specs are held outside North America for FM 4991 Approved Firestop Contractors and/or UL Qualified Firestop Contractors, it helps everyone.




