

Throughout North America, specifications in MasterFormat Section 07-84-00 call for a 'FCIA Member in Good Standing'. When meeting in November 2012, the FCIA 2012 Board voted new requirements for 'Member in Good Standing' to add value to membership. To attain 'Member in Good Standing' status, members joining after Dec. 21, 2012 must have paid dues for at least the previous two years. This helps provide value to members who continue membership.
