FCIA Barrier Management Symposium: Next Stop Long Beach, CA

The Joint Commissions #1 and #2 Survey Violations are penetrations and door issues in fire and smoke barriers. Fire and smoke barriers are there to protect healthcare building occupants and staff, and if the barriers are compromised, your end user is relying on an unreliable system.

After seeing the staggeringly high number of violations, FCIA and The Joint Commission, along with the American Society of Healthcare Engineers (ASHE) and Underwriters Laboratories created The Barrier Management Symposium to better educate healthcare building engineers, Building Officials and Fire Marshals on how Barriers are Designed, Installed, Inspected and Maintained (DIIM).

The next Barrier Management Symposium will be taking place in Long Beach, CA at the Queen Mary, and is sponsored by the California Society of Healthcare Engineers (CSHE). The upcoming program promises to bring together another great panel of speakers dedicated to the education of the healthcare industry about the necessity of continuity in fire and smoke barriers.

Network with your peers and beef up your code knowledge. You'll want to be at this event.


