FCIA Prepares for ICC Public Comment Hearings

FCIA's <u>Code Committee</u> submitted a public comment to the <u>ICC's Fire Code development process</u>. The proposal aims to add the word 'inventory' of fire-resistance-rated

assemblies. The public comment is to the ICC's Fire Code Action Committee proposal F113-16.



Under the proposed section 701.6, Owners Responsibility,

"The Owner shall maintain an inventory of all required fireresistance-rated and smoke-resistant construction, and the construction in sections 703 through 707...." The intent is to have documentation that the building owner and manager has an inventory of these assemblies and where they're located. This sets up an easier path to compliance with the code requirement that such construction "shall be visually inspected by the owner annually, and properly repaired, restored or replaced where damaged, altered, breached or penetrated." If the building owner and manager does not understand where the barriers are, how can they be inspected and meet the code requirement in the International Fire Code, 703.1?

In a second proposal under the 703.1, Maintaining Protection, "Where the system design number is known, the system shall be inspected to the listing criteria and manufacturers installation instructions".

FCIA's Code Consultant worked with the FCIA Code Committee and Staff to put forward these proposals and are aimed at building better reliability of installed firestop systems. Both key concepts were recently supported by the IC's Western Region Working Group of AHJ's and interested parties. This is a good sign for the upcoming ICC Public Comment Hearing in Kansas City. Be sure to attend FCIA's FIC 2016 to hear the update of the hearings from Bill Koffel.

FCIA at National Building Code of Canada Code Development Process

The <u>FCIA Canada Committee</u> has submitted four <u>code</u> <u>development proposals</u> for inclusion in the <u>National</u> <u>Building and Fire Code of</u> <u>Canada</u>.

The first proposal covers an addition of the 'Design, Installation, Inspection and Maintenance' of firestopping using the Installation and Inspection pieces of the 'DIIM'



puzzle. The proposal introduces adding the third-party accreditation programs - <u>ULC Qualified Firestop Contractor</u> <u>Program</u> and <u>FM 4991</u>, <u>Standard for the Approval of</u> <u>Firestop Contractors</u> - for installation. Additionally, the ASTM E 2174 and ASTM E 2393, Standards for the On-Site Inspection of Installed Penetration and Joint Firestop Systems for inspection were submitted for consideration.

The second proposal deals with the terminology used to

describe the 'opening' around a penetrating item or a joint area. Before a 'penetration' can take place, a breach of the fire separation must be made, therefore, we've added the word breach to the sections in the code where firestop systems are described for both the 'penetrations' and 'joints'.

Third, the word 'Firestop' has been submitted to replace the word 'Fire Stop'. The ULC Standard, CAN/ULC S-115, is named, "The Standard Method of Fire Tests of Firestop Systems". The Standards Council of Canada also recognizes S-115 as the "STANDARD METHOD OF FIRE TESTS OF FIRESTOP SYSTEMS". The manufacturer's literature also states that 'Firestop Systems' are sold by the many who have invested in this industry. Industry trade associations, including the Firestop Contractors International Association and International Firestop Council, are both spelled with one word.

Finally, in the National Fire Code of Canada, FCIA's Canada Committee submitted that an inventory of fire separations be assembled and kept by the building owner and manager. Documentation would be needed to show the compliance with the NBC and NFC on fire separations and the features of fire-resistance.

Canada's Code Development Process for the 2020 National Building Code of Canada is just starting. Look for more as discussion at the Standing Committee on Fire Protection at the National Building Code of Canada continues. Joint Commission Eliminates Plans for Improvement



The Centers for Medicare Medicaid Services ENTERS FOR MEDICARE & MEDICAID SERVICES (CMS) has asked The Joint Commission (TJC)

The Joint Commission to

to make several changes its <u>Statement</u> of **Conditions** process, and

the Joint Commission will no longer consider hospital Plans for Improvement (PFIs) starting August 1. Instead, all life safety deficiencies will need to be corrected within 60 days, although a time-limited waiver process will be available through CMS regional offices.

George Mills, MBA, FASHE, CEM, CHFM, CHSP, director of

engineering with the Joint Commission's Department of Engineering, announced the major changes at the ASHE Annual Conference this July. Under the new process:

- Deficiencies will need to be corrected within 60 days of being identified unless the CMS regional office approves an extension.
- All requests for extensions will be handled by CMS regional offices; however, the Joint Commission will allow facilities to submit requests and receive a receipt to show they are in the pipeline waiting for an extension.
- The Joint Commission will not review open Plan for Improvement (PFI) items, and PFIs will not be a part of final reports.

The changes became effective August 1. The Joint Commission is an accrediting organization that has deemed authority from CMS and must meet CMS requirements. Mills said the PFI process can still be used as an internal management process.

NFPA 1 Fire Code

The agenda for the upcoming NFPA Technical Committee Meeting was recently released. There we no Public Comments submissed on the First Draft Meeting regarding change to the fire protection features inepsction frequency. The frequency proposed was to reduce from every 5 years to every 3 years. Watch for more info as the NFPA 1 Development Process completes soon.

ASHE's Focus On Compliance



Fire and smoke barriers and their protective opening devices in hospitals and other health care facilities are key elements of the

structure. They protect occupants from the products of fire and combustion and are used for the horizontal evacuation of those in compromised areas. These barriers and their protective opening devices comprise the effective compartmentation that allows defend-in-place strategies to be safely employed.

A review of the 2014 Joint Commission survey data indicates key areas of noncompliance to Standard LS.02.01.30 in the areas of penetrations within fire and smoke barriers and fire and smoke barrier door failures. Standard LS.02.01.10 includes many related issues, so Focus on Compliance resources available for these standards can be found on the ASHE and FCIA websites. Within the Barrier Penetrations section on the <u>American Society of</u> <u>Healthcare Engineers (ASHE)</u> website is FCIA's 'DIIM' Presentation, 'FCIA's Firestopping Education for ASHE <u>Members'</u>.

FCIA's Barrier Management Symposiums have made a difference. Healthcare building owners and managers are understanding how to buy this specialized service. Why? Firestop Systems are much more than 'Fire Caulk'. It's about the 'SYSTEM' and documentation, not just the material.

Joint Commission Surveyors Ask 3 New Questions

The Joint Commission Life Safety Surveyors are now asking three new questions before starting building tours:

- What type of firestopping is used in the facility? (Aka what type of firestop systems are used as a part of the facilities barrier management system?)
- What is the organization's policy regarding accessing interstitial spaces and ceiling panel removal?
- Which materials are used (glutaraldehyde, orthophthalaldehyde (OPA), peracetic acid, etc.) for highlevel disinfection or sterilization?

FCIA has been working with the <u>American Society of</u> <u>Healthcare Engineers (ASHE)</u> and <u>The Joint Commission</u> (TJC) to educate facility directors, surveyors and also the industry about Firestopping and Firestop SYSTEMS.

In fact, ASHE recommends, "For more information and resources on barrier management or other compliance topics, visit ASHE's Focus on Compliance project, a collaboration with the Joint Commission. Check out this focus on LS.02.01.30 compliance as it takes the reader to the method to restore fire-resistance to breaches – FCIA's Firestop DIIM Presentation."
